
How leaving a gift to Severn Hospice will make a difference

Why write a will?

Writing a will enables you to communicate your final wishes, helps you look after your loved ones and provides you with peace of mind. You may wish to distribute assets to family and friends. Every year hundreds of supporters go one step further and choose to support Severn Hospice with a gift in their will.

When to write a will?

Writing a will is one of the most important life admin tasks you will ever do and everyone over the age of 18 should write a will.

Moving house, getting married, having children, losing loved ones? These are milestones when you should consider writing or updating your will.

How to write a will

Once you have collated your key assets, our handy estate checklist can help you. There are two main ways to create your will:

1. Contact a solicitor of your choice and arrange a meeting to create your will. Don't forget to take all of your estate information and wishes with you.
2. Create a free basic will using our online service provided by our partners at Octopus Legacy.
